MEMBERSHIP APPLICATION & WAIVER OF LIABILITY
A Binding Legal Document

I the under-signed member of OCRDA as a voluntary participant from time to time in the various activities of the club hereby acknowledge my comprehension and understanding that motorised sport in general can be hazardous to health and I recognise that in participating in such activities I expose myself to the significant risk of physical injury including the potential for partial or total disability, paralysis and death, as well as damage to or loss of my boat and personal property and that I understand that these risks and dangers may be caused by my negligence or the negligence of others including the club, members agents, employees, other volunteers or affiliates (hereinafter referred to as "the releases" or by accident, mechanical failure, adverse weather, misadventure, recklessness, deliberate act, carelessness or inexperience of any participant including myself, and by duly signing this document, I confirm that in participating in any capacity whatsoever in all or any of the clubs activities I knowingly and freely assume and accept all such risks, both known and unknown.

I confirm and I accept that it is my sole responsibility to ensure that any boat I am using, whether the property of myself or another, is in good condition, well maintained and fit for any club activity in which I participate and is fully insured against all third party risks, that I carry suitable personal accident insurance cover and I hereby so certify that this is the case.

I acknowledge that I understand that the activities of the club are organised gratuitously and that the decision to take part in any event, whether as an official, competitor, driver or passenger in my own or a boat belonging to another, is mine alone and at my own risk.

I hereby undertake to comply with the general rules and constitution of the club and to observe and comply with all such conditions and rules as may be laid down by the organisers for the proper and safe conduct of any specific event.

I hereby release discharge and hold harmless the releases from and against any and all claims, liability and/or causes of actions I may have or that may be made on my behalf or by my spouse, partner, children, heirs and legal representatives, for death, wrongful death, personal injury whether physical, emotional and / or psychiatric or any combination or indirectly out of or incidental to my participation in any of the activities of the club whether or not resulting from or caused by negligence by, of and / or on the part of any release or releases.

I further agree to defend indemnify and hold harmless the releases or any of them from any and all claims, actions, suits, costs, expenses, damages, liabilities and demands brought as a result of my participation in any way in any activities of the club and I agree that this agreement may be pleaded as a bar to any action, suit, proceedings taken against any release by me or on my behalf.

I further expressly agree that the foregoing waiver, assumption of risks, release and indemnity agreement is intended to be as broad and inclusive as is permitted by the UK law and that if any portion thereof is held to be invalid, it is agreed that the balance of this document shall, notwithstanding, continue in full force and effect.

I agree that this document binds my heirs, administrators, executors, personal representatives, dependants (if any) and successors and endures for the benefit of the releases or any of them and their successors and assigns for the season.

I have read and do voluntarily agree to the above release and waiver of liability, assumption of risks, release and indemnity agreement, and further state and agree that no oral representations, statements, apart from those contained in the above document have induced me to enter into such an agreement.
